On 06.12.2021, the [International Criminal Court](http://www.icc-cpi.int) in The Hague received the [complaint](#) of various British citizens against various defendants, including Boris Johnson, Bill Gates, Tedros Adhanom Ghebreyesus, as well as the CEO of the manufacturing companies of the well-known Corona vaccines. Representing the lawsuit are Dr Mike Yeadon, the former vice-president and head of research at Pfizer, Mark Sexton, a

retired police officer, John O'Loony, a funeral director, Louise Shotbolt, a nurse and activist, and [Hannah Rose](#), a lawyer and human rights activist, among others. The complaint alleges various crimes arising from violations of the Nuremberg Code and Articles 6, 7 and 8 of the Rome Statutes, including genocide, crimes against humanity and war crimes committed by Pfizer, Johnson, AstraZeneca and Moderna in administering the Corona vaccines.

Below I am posting excerpts from the German translation of the statement of case filed by Dr Mike Yeadon, lawyer Hannah Rose and others ... before the International Criminal Court. Attention, these are very profound allegations ... this is not for the faint-hearted! For the time being, this is only about the United Kingdom of Great Britain. However, legal assessments of the International Criminal Court (ICC) would also be binding for other states that have submitted to the jurisdiction of the ICC in comparable cases. The D-A-CH states are among them!
